Special Remarks on other Toxic Effects on Humans: Acute Potential Health Effects: Skin: May cause mild skin irritation.
Eyes: May cause mild eye irritation.
Inhalation: May cause respiratory tract irritation. Symptoms may include coughing and sneezing.
Ingestion: Symptoms of overexposure to Potassium Bicarbonate include thirst, abdominal pain, gastroenteritis, and inflammation of the digestive tract.
Chronic Potential Health Effects: Skin: Repeated or prolonged skin contact may cause irritation, drying or cracking of the skin.
Ingestion and Inhalation: Chronic toxicity usually occurs within 4 to 10 days following ingestion of very large amounts. Repeated or prolonged ingestion or inhalation of large amounts may cause metabolic abnormalities, and Potassium retention. Metabolic abnormalities such as acidosis, hypernatremia, hypochloremia, alkalosis, hypocalcemia, or Potassium retention may affect the blood, kidneys, respiration (cyanosis, apnea secondary to metabolic acidosis or pulmonary edema), and cardiovascular system

(tachycardia, hypotension). Severe toxicity may also affect behavior/central nervous system/nervous system. Neurological changes may result from metabolic abnormalities.

These may include fatigue, irritability, dizziness, mental confusion, paresthesia, seizures, tetany, cerebral edema Medical Conditions Aggravated by Exposure: Persons with pre-existing skin conditions might have increased sensitivity. Predisposing conditions that contribute to a mild alkali syndrome include, renal disease, dehydration, adn electrolyte imbalance, hypertension, sarcoidosis, congestive heart failure, edema, or other Potassium retaining conditions.
